Getting to Know Stacy Wallach


STACY IS A MAN FOR ALL SEASONS!

He is a lifelong student of history, a former Manhattan litigator, a retired real estate executive and, at present, an adjunct professor at Pace University Law School. Stacy earned a BA, *magna cum laude*, at Swarthmore College in Pennsylvania where he majored in history, political science and economics. He then graduated from the University of Pennsylvania Law School and practiced law in New York City.

In his mid-forties, Stacy served as Senior Vice President, general counsel and member of the Board of Directors of the Edward S. Gordon Co., a leading commercial brokerage firm, and then as Senior Managing Director, Brokerage Operations/New Jersey at CB Richard Ellis, Inc., the largest commercial real estate services firm in the world. For many years, he volunteered his time as a New York City Small Claims Court arbitrator and Federal District Court mediator.

Stacy is a frequent OLLI lecturer. His diverse background, his extensive research into historical time periods, his love of PowerPoint illustrations to enliven his lectures and his dynamic personality combine to make his OLLI courses exciting, stimulating and popular. He particularly enjoys delving into an unusual thread or theory in a specific time period and has taught courses including *A Look at America's Birth: 1788 to 1805* and *The Gilded Age: The Emergence of Modern America*. He is currently preparing a course for the spring 2012 semester on a little known but critical incident early in World War II when Germany might have had its best opportunity to win that war.

A guest lecturer for the Distinguished Speakers Series, Stacy's topic was *From Ironic to Iconic: An Idiosyncratic Look at the History of Manhattan Skyscrapers*, which he will also present in January at the annual



meeting of the New York State Bar Association in New York City.

In addition to presenting OLLI courses, Stacy volunteers at the Learning Ally (formerly Recording for the Blind & Dyslexic) in Lenox. He enjoys tennis, hiking, biking, skiing and, most of all, being with his family. He also has a great concern for those people sometimes overlooked in our community.

We at OLLI are fortunate to be the recipients of Stacy's knowledge and enthusiasm for teaching history.

President Raverta—Thank You and Farewell

WHEN The Bernard Osher Foundation insisted that the independent corporate entity Berkshire Institute for Lifetime Learning (BILL) become an integral part of an acceptable institutional parent as a condition of becoming an Osher Lifelong Learning Institute (OLLI), it was Paul Raverta, President of BCC, who very quickly grasped the major favorable impact this would have on the long-term future of lifelong learning in the Berkshires. When asked, he unhesitatingly agreed to accept BILL and merge it into BCC as OLLI at BCC.

WHEN the Osher Foundation expressed concern about academic programming and the financial management capabilities of what would become the first major regional community college in their star-studded galaxy of top educational institutions in the country, it was President Raverta who pulled together

the appropriate staff to prepare an outstanding summary of what BCC is all about. It very quickly allayed any concerns within the Osher Foundation, and today BCC stands with the best educational institutions in the country as the home of a very successful OLLI.

WHEN it became necessary to develop a mutually satisfactory Affiliation Agreement involving BILL, BCC and the BCC Foundation, it was President Raverta who was instrumental in cutting through many complex issues to assure that the excellent educational and operational management developed within BILL was suitably incorporated into the merged entity. He has, in the years since, provided strong leadership and support throughout the college and, as a result, OLLI at BCC has grown and received major financial



support from The Osher Foundation; support which assures the long-term viability of lifelong learning in this community.

Those of us who worked diligently to bring about the transformation from BILL to OLLI

at BCC are sincerely grateful for the strong leadership provided by President Raverta in making this all possible. OLLI at BCC wishes him and his family many years of good health and much enjoyment in their long-delayed retirement. He takes with him all of our good wishes and the certainty that he leaves a legacy that will not be forgotten.

Story Musgrave

Astronaut Story Musgrave's life is filled with facts and deeds that seem beyond reality; but this information came from e-mails and website links from the astronaut himself.

Story was born in 1935 on a dairy farm at the Linwood Estate in the Glendale section of Stockbridge, now the location of the Norman Rockwell Museum. As a 5 year old, he remembers lying on his back on the plowed fields looking at the stars. "I didn't have any idea what a star was. I didn't have any knowledge. It was just awe and wonder." By age 10, he had built river rafts, worked on farm machinery, operated combines, had driven tractors and trailers and by age 13 he repaired them.

Story's early school life was not successful in the usual sense; he hated school, got in trouble, dropped out of St. Mark's School, a boarding school in Southborough, Massachusetts, and joined the Marines in 1953. He credits the discipline of the Marines with providing the foundation for his future work. He loved planes and mechanics and developed a desire for higher education. When he learned that Syracuse University had a program for servicemen, he took and passed the Massachusetts high school equivalency test and was accepted at Syracuse for the class of 1958.

That was only the beginning of his higher academic achievements. He earned graduate degrees in mathematics, computers, chemistry, physiology, literature and psychology, and he has a medical degree from



Columbia University Medical School.

During Story's medical internship in 1964, he read that NASA was looking for scientists to join the astronaut corps and so he discontinued his internship in order to study aerospace physiology. He realized "I was a spaceperson, that's me...from aviation education to medicine. I could see that everything I've done in life, I can apply to this new job." He joined NASA in 1967, and was one of 11 people selected out of 4,000 applicants. His new job involved work on spacesuit technology and testing and developing shuttle software and other research. In 1983, he took the first of his six space flights where he could test and use the spacesuits he had designed.

His first flight was on the maiden

voyage of the space shuttle Challenger in 1983 where he and a fellow astronaut took the first memorable steps outside the spacecraft doing somersaults as they worked their way along the payload bay; in 1985 he was the flight engineer on his second Challenger mission. In 1989 and again in 1991 he was aboard Discovery involved in radiation and medical experiments; and in 1993 he was the payload commander for the famous Hubble Telescope repair mission and remembered, "that the little Linwood boy, that St. Mark's dropout, gets to do this is still a dream." In 1996 on the Columbia, his last space voyage, he worked on experiments to study the origin and composition of the stars—perhaps to find the answers to his boyhood questions—the unending wonder and search for knowledge that persists in his life today.

Story left NASA in 1997 after 30 years with the program. Since then he has continued his intellectual and physical pursuits in a multitude of activities—producing media, teaching, corporate presentations, parachuting, writing and many others.

His family includes his wife Amanda, seven children ages 4 to 50 years and three grandchildren. He now lives in Florida and makes periodic visits back to the Berkshires.

One of his favorite quotations exemplifies his philosophy, "Live in the moment, the past is history, the future a mystery, the destination unknown. Life is about the journey."

With an endowment of \$2 million, why does OLLI need to charge membership dues and class fees?

The principal of the \$2 million endowment cannot be invaded by the terms of our agreement with The Osher Foundation. Only the income from the endowment investment can be spent in a given fiscal year. OLLI had estimated a return of 5 percent

on the endowment for this year, but in this financial climate the return will surely be diminished. OLLI must charge membership dues and course tuition to help cover its operating costs which include staff salaries and benefits, audiovisual and editing equipment, printing costs of catalogs and newsletters, postage, advertising and other instructional related expenses. — Norman Michaels, Treasurer

Why does OLLI charge a percentage over its discounted costs for Special Events or similar events?

All programs and activities are structured to help defray OLLI's operating expenses. Members who take courses pay through course fees. Special Events and other programs are set at approximately 10 percent above costs for this same purpose. — Norman Michaels, Treasurer

What are some of the major differences among the 117 OLLIs?

Each OLLI organization reflects the culture of its own learning community. Many OLLIs are lecture-based as is ours; others are built around the Study Group Model and some offer a preponderance of "hands on" courses. Some teach exclusively on their host campus and pay instructors from that college's programs to teach. Others have multiple sites and some, like ours, do not pay their instructors. Membership dues and tuition fees also vary widely depending upon the instructional costs.
